#### CLEVELAND-CUYAHOGA COUNTY PORT AUTHORITY BOARD OF DIRECTORS MEETING Thursday, February 9, 2023

The Meeting of the Cleveland-Cuyahoga County Port Authority Board of Directors was held at the Port Offices (1100 W. 9<sup>th</sup> Street) on Thursday, February 9, 2023 with notice of the meeting information provided to the public in advance. Having given notice at least two days prior to the meeting and not having previously attended remotely more than 3 times during the past 12 months, Director Copeland attended the meeting remotely via Zoom and gave the proper password. Prior to the meeting, Director Copeland was provided with all meeting-related materials. Director Copeland confirmed she was more than 1/4 mile from the primary meeting location at 1100 West Ninth Street, Cleveland, OH and had internet access to receive any material distributed at the meeting, It was then verified that all Board members could hear and be heard by all other members in attendance. #### APPROVAL OF MINUTES

The minutes of the Board of Directors meetings of December 16, 2022 were presented for approval by the Board, copies having been delivered in advance to all Directors. On motion by Director Wondolowski, seconded by Director Zone Fisher, and unanimously carried by roll call vote, the Minutes of December 16, 2022 were approved.

#### PUBLIC COMMENT PERIOD/CHAIR COMMENTS

There being no public comment, Chairman Holmes proceeded with the Agenda.

#### PRESIDENTS COMMENTS

Mr. Friedman addressed the Board and provided an update regarding Irishtown Bend litigation. The Osborne Engineering team is working to complete additional design elements, including a wall structure, in the event it's necessary to build around the property at the top of the hill. An update on the conclusion of their design should be ready for the March meeting. There continues to be discussions between the litigating parties regarding a settlement.

Upcoming in March, CEO performance goals are formally adopted by the Board and there will also be officer elections. Officers typically serve two-years in office and there is an election/re-election every March.

#### MARITIME COMMITTEE

Agenda Item 4(C)(1)(a) - Seamen's Service

Mr. Jared Magyar addressed the Board and introduced Mr. Tim Mohr and Eric Kreutzman, both of Seamen's Service. Mr. Mohr addressed the Board and referred to a presentation attached hereto as "Exhibit A". Mr. Mohr thanked the Port for supporting their 60 years of service. Chairman Holmes stated he's grateful for the passion of the volunteers and is appreciative of their continued dedication. Mr. Friedman also thanked Seamen's Service and stated merchant mariners have a very tough job, and they're very fortunate to have services available to them.

Mr. Gutheil addressed the Board and recognized Mr. Magyar and his team for their hard work to ensure daily operations are seamless. Mr. Gutheil then referred to a presentation attached hereto as "Exhibit B" (slides 1-4). Director Zone Fisher asked whether the passenger fee is paid when the vessel arrives in port. Mr. Gutheil replied no, the fee is built into the cruise cost. Chairman Holmes asked how the Port of Cleveland security fee compares to that of other ports. Mr. Gutheil replied that Cleveland's fee is on the low to medium side compared to others.

Mr. Gutheil then referred to a presentation attached hereto as "Exhibit B" (slides 5-9). Director Thomas stated that the increase in cruise calls is impressive and asked whether it's the result of an intentional business strategy or just the market finding its way back from the pandemic. Mr. Gutheil replied it's both. Last year the Port Authority and the St. Lawrence Seaway met with three cruise lines and asked them to call Cleveland. Viking was already on the schedule, and the other two lines were added following the discussion. The Port doesn't make much revenue on the cruise business, it's more for the local economy and the economic impact of the customers visiting the city. Director O'Malley asked how many cruise calls were in 2022. Mr. Gutheil replied 37.

## Claire MacMurray Howard, 104, author, started Seamen's Service

Claire MacMurray Howard. 104, former Plain Dealer columnist, best-selling author and founder of Cleveland Seamen's Service, died vesterday at her home in Cleveland.

From 1936 to 1965, using Claire MacMurray as her byline, she wrote "Good Morning." which she once described as "a housewifely column, written in the present time as though I was talking to a friend."

Her first book, "And Beat Him When He Sneezes," a compilation of columns that focused on the antics of her three sons, was published in 1941

It was on a national bestsellers ist for seven months, translated nto Braille and sent to overseas ibraries as an example of the merican way of life. The book lso inspired a family comedy sees. "Nichols Family of Five." at aired nationally on NBC ra-

Her second book, "Out on a mbo," printed in 1944, was on e bestseller list twice as long as



## Tariff Modifications

- Port staff reviews tariff annually
- Last revision in 2022
- Substantial changes have occurred to operation
- Increased activity at general cargo dock
- Changes in tariff necessary due to increased costs & activity





## **Tariff Modifications**

- Truck fee increase from \$60.00 to \$65.00
  - Credit card or commercial check
- Removal of reference to Buckeye Booster
- Cruise passenger fee increase from \$12.50/passenger to \$15.00/passenger
- Change verbiage for use of Dock 28
  - Priority for cruise vessels requiring CBP
- Increase in hourly crane charge from \$175.00/hour to \$195.00/hour
- Facility security fee increase from \$28.00/hour to \$30.50/hour (1 guard) or \$56.00/hour to \$61.00/hour (2 guards)
- Changes take effect April 1, 2023


## 2022 Review

#### General Cargo

- Steel demand strong in local market
- Transatlantic container demand & rates still strong – Transpacific market has stabilized
- POC taking advantage of congestion
- FTZ storage has occurred mostly in 3<sup>rd</sup> &
   4<sup>th</sup> quarters year end inventory push
- Salties and barge calls both increased
- Cruise industry rebounded 37 visits & 5116 passengers

#### CBT


- Tonnage decrease due to maintenance on furnace at Cliffs steel mill until August 1 and loss of limestone business
- Tonnage rebounded last 5 months of 2022





## **Industry News**

- GLSLS tons in 2022 = 5% decrease/36M MT
  - Iron Ore and Grain decreased
  - General Cargo decreased 22%
- Congestion at west coast ports has subsided
- Container sector
  - Top 9 lines control 83% of capacity
  - Opportunities for niche lines
  - Trans-Pacific Rates have returned to pre-COVID levels
  - Trans-Atlantic rates remain strong helps CEE
- More discussion of short sea service within
  - GLSLS green corridors
- Labor contract negotiations in process at west coast and Great Lakes ports
- Trucking and rail industry staffing issues affecting supply chains





## 2023 Outlook

- Steel importers cautious in 2023 due to inflation concerns & slowing economy
- Container volume room for growth in exports vessels full WB
  - Search for "niche" cargoes
- Bulk liquid cargo start-up in April
- Limestone cargo at CBT lost due to energy plant shutdown on Ohio river
  - Working on new cargo as replacement
- 53 cruise vessel calls scheduled for 2023
- Maintenance pursuing parts sharing program with other GL ports
