#### APPROVAL OF MINUTES

The minutes of the Board of Directors meetings of September 9, 2022 were presented for approval by the Board, copies having been delivered in advance to all Directors. Director McNair recommended a correction to page five (5) of the draft minutes to note that Resolution 2022-25 was voted down as opposed to being tabled. With that change, on motion by Director Copeland, seconded by Director McNair, Director O'Malley abstaining from the vote, and unanimously carried by roll call vote (5-0) with Directors Thomas and Wondolowski concurring with the majority vote on the phone, the Minutes of September 9, 2022 were approved.

#### PUBLIC COMMENT PERIOD/CHAIR COMMENTS

There being no public comment, Chairman Holmes addressed the Board and audience.

#### **CHAIR'S COMMENTS**

Chairman Holmes thanked staff for planning the Board Orientation and noted it was extremely beneficial for those who attended. Director Zone Fisher agreed.

Mr. Friedman addressed the Board noted there will be a strategic planning session immediately following the Committee Reports at the November 10, 2022 Board Meeting.

#### **BUDGET & ADMINISTRATION COMMITTEE**

Agenda Item 4(C)(1)(a) - Community Investment Fund

Mr. Davis addressed the Board and referred to pages 6-7 of the Board Agenda. Chairman Holmes noted the project is a great way for the Port to reinvest in our region, and a wonderful opportunity to partner with the Cuyahoga Land Bank. Director Jackson asked what the total budget is for the project. Mr. Davis replied \$3.5 million is the estimate for the building. Director Copeland stated she is extremely pleased with the direction the Community Investment Fund has headed. She thanked Mr. Davis for his work on securing the partnership.

On motion by Director Copeland, seconded by Director Zone Fisher, with Director McNair abstaining from the vote, and unanimously approved by roll call vote

#### **RESOLUTION NO. 2022-28**

#### **MARITIME COMMITTEE**

Agenda Item 4(C)(2)(a) – Cleveland Harbor Eastern Embayment Resilience Strategy (CHEERS) Approval of Award of Contract for Design and Permitting

Ms. Sternheimer addressed the Board and welcomed guests and invited them to address the Board if they'd like. Ms. Joyce Huang, City Planning Director for the City of Cleveland stated she and her team have been extremely engaged in the CHEERS development process. She believes the Port engaged in a robust RFQ process and they support the selection of Arup and support moving forward with the process. Ms. SeMia Bray, Co-Director at Black Environmental Leaders, addressed the Board. She stated that CHEERS represents an opportunity to transform an area of Cleveland that was created out of segregation. CHEERS will be a collaborative effort to finally transform the area to one of community, where residents can enjoy the amenities of the lakefront.

Ms. Sternheimer then introduced Mr. Vincent Le, Associate Principal at Arup. They each addressed the Board and referred to a presentation attached hereto as "Exhibit A". Director McNair stated that he appreciated the presentation. Reflecting back to the September Board Meeting, he stated that he didn't feel there was adequate representation from the groups coming forward, and there was a lack of clarity with respect to how partners would each be participating. The Port Authority takes inclusion very seriously, and we must lead by example. Director McNair stated he was impressed with today's presentation and the attention to detail. Director McNair asked that Staff take note of what the Board expects when projects like this are presented in the future. Chairman Holmes thanked Director McNair for being deliberate and intentional in keeping focus on the issues of inclusion. He also thanked Mr. Le for his impressive presentation and noted that he and Arup should be very proud of their intentional work with to respect diversity and inclusion. Director Copeland noted she was impressed by today's presentation. It was a meaningful and impactful way to present.

Cleveland is setting the standard for how sediment can be reintegrated into the community. Mr. Friedman stated that without this operation there could be no dredging, and without dredging there is no maritime industry. It is very important work.

- SOW: Complete 90% design & shovel ready for the in-water containment structures

## CHEERS// Recommendation

Board of Directors is being requested to approve Resolution 2022-29 authorizing the execution of an agreement with Arup for the purpose of undertaking the scope of work for design engineering and permitting services for CHEERS to in and amount not to exceed \$3,734,833.



# IRISHTOWN BEND// Change Order

- Change order is for the design task to evaluate and recommend hillside stability repairs assuming no access to the Royal Castle Property including the design of a midslope wall
- Geotechnical assessment to determine the exerted forces on the wall, revisions to the bulkhead and adjustments to the civil grading and drainage improvements and other repairs as required.
- Additional fee is \$350,000
- Schedule 3-4 months
- Design funds will come from state capital funds in partnership with the Ohio Department of Natural Resources
- Money to construct is not yet secured



# IRISHTOWN BEND// Recommendation

Board of Directors is being requested to authorize and approve Resolution 2022-30 a modification of an existing contract with Osborn Engineering as a change order in an amount not to exceed \$350,000 and authorizing the expenditure of funds from certain grant funds to be received and authorized by Resolution 2019-13.





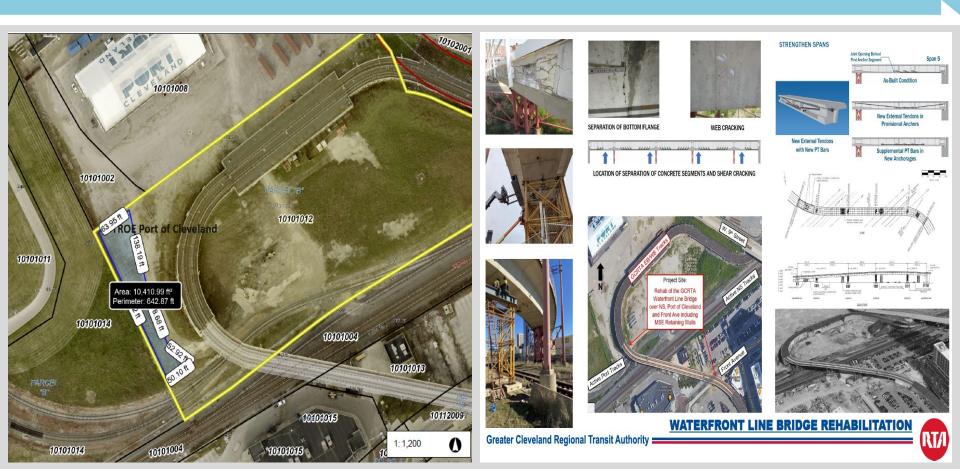


# **Board of Directors Maritime**

October 13, 2022

- GCRTA Waterfront Line requires repair and rehabilitation
- Waterfront Line bisects Dock 22 south on Port property
- Bridge is 645' long and moves over Front Ave., NS railway, and Port rail tracks
- Details of work include:
  - Bridge work repair and strengthening including those over Port rail tracks
  - Wall rehab both north and south facing walls on Dock 22 south
  - Rail replacement on approaches to wall and across wall structure
- Work requires access to Port property on Dock 22 south
  - Includes storage of equipment & space required for work
- Port operations will continue unencumbered
- Some cargo may be temporarily relocated
- Rail cargo will move uninterrupted
- GCRTA will be Port License fee of \$3,500.00/month for duration of project
- Project will commence November 1, 2022, and conclude by October 1, 2023

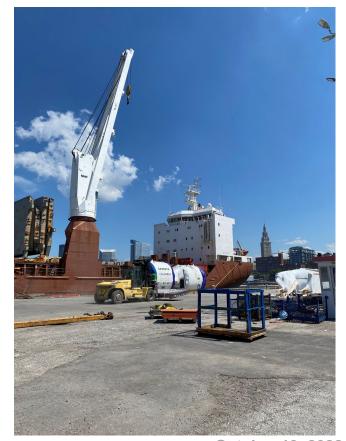

# 2022 YTD Maritime Update – through September

## TONNAGE REVIEW (METRIC TONS)

- GC Tonnage
  - 48% increase vs. 2021 levels
- CBT
  - Tonnage down due to idle furnace at steel mill
  - Back on line early August
- Containers (TEU)
  - o Imports up 300% vs. 2021
  - Exports up more than 10X 2021 levels

# Port of Cleveland Sediment Processing & Management Facility: Need & Role

- 250,000+ Cubic Yards (CY) Material Dredged Annually
- Navigation Channel <u>Must</u> be Dredged 2X Per Year to Sustain Maritime Commerce
- Port Authority Beneficially Harvests 40%-60% of Dredge Sediment Received & Permanently Landfills Balance at Sediment Processing & Management Facility
- Upland Placement into Port Authority's Facility is the <u>Only</u> Short & Medium Term Viable Alternative to Manage Dredge Sediment in Cleveland Harbor
- Key Beneficial Use Benefits:
  - Reduced Consumption Rate Limited Remaining CDF Capacity
  - Semiannually Regenerates Capacity
- Dredge Material Management is Critical to our Regional Economy & is a Key Component of Port Authority's Strategic Plan



# Port of Cleveland Sediment Processing & Management Facility: History & Performance

## SPMF PERFORMANCE



- Sediment Processing & Management Facility Scaled Operation Began In 2015
   & Scaled Up In 2017
- Kurtz Bros. Inc. has Served As Beneficial Use Site Operator Since Inception
- Since 2015 Received 1.44M CY Dredge Sediment of which 922K Beneficially Harvested & Removed Facility



# Port of Cleveland Sediment Processing & Management Facility: Site Operation Agreement

- Kurtz Bros., Inc. (KBI) comes to the end of their 5 year Operating Agreement in December 2022.
- In accordance w/ Ohio Revised Code Port Authority publicly advertised for Statement of Qualifications from qualified site operators
- Port Authority received a single submission from Kurtz Brothers, Inc. (KBI)
- KBI submission was internally reviewed, scored, and found to be fully responsive to the Port Authority's SOQ request
- Port Authority subsequently entered contract and fee negotiations w/ Kurtz Brothers for new 5 year Operating Agreement

# Site Operation Agreement Other Key Details:

- 5 Year Site Operations Agreement Term
- Increased expectations & commitments by KBI to invest in new equipment & added personnel to better maintain Facility's roadway network, reduce fugitive dust generation, and reduce material track out onto public right of way
- Kurtz responsible for obtaining beneficial use permits from OEPA and required to perform all required soil testing.
- Annual Commitment to Port Authority Living Wage Policy & 30%+ MBE & FBE Subcontracting Goal
- Continued commitment to beneficially harvest & remove up to 160,000 CY/year & semiannually prep facility for hydraulic receipt inbound placement of dredge sediment
- Transparency measures preserved in Agreement to track material being sold directly from the Facility and those materials moving into Kurtz Brothers other lines of business
