APPROVAL OF MINUTES

The minutes of the Board of Directors meeting of July 13, 2023 were presented for approval by the Board, copies having been delivered in advance to all Directors. On motion by Director Copeland, seconded by Director Zone Fisher, and unanimously carried, the Minutes of July 13, 2023 were unanimously approved.

PUBLIC COMMENT PERIOD

There being no public comment, Chairman Holmes proceeded with the Agenda.

CHAIR'S COMMENTS

Chairman Holmes addressed the Board and Staff and noted that it's been a busy and productive summer. He thanked everyone for their dedication and hard work.

PRESIDENT'S COMMENTS

Mr. Friedman addressed the Board and mentioned that the Groundbreaking Event for Irishtown Bend was well attended and very successful. We're very happy that work is now underway. Chairman Holmes noted that he read about artifacts that were uncovered while digging at Irishtown Bend and asked whether there was additional information. Ms. Sternheimer addressed the Board and stated that sixty thousand pieces of material were found, however none were fully intact. A report of all material found will be compiled.

REAL ESTATE & DEVELOPMENT FINANCE COMMITTEE

Ms. Winslow replied it may be the first, and if not, it's definitely the first in a number of decades. Director O'Malley asked when the water park is scheduled to open and what other traffic is driving the need for the hotel. Mr. Ryan Kaplan replied in 2025. The Hall of Fame hosts a variety of high school football events, football camps, concerts and other large events. Director Zone fisher added that the First Lady Library and Museum also draws many attendees throughout the year.

MARITIME COMMITTEE

Agenda Item 4(C)(2)(a) — Customs & Border Protection Lease Agreement for Cargo & Administrative Facilities

Chairman Holmes requested that the Minutes reflect that Director O'Malley is now in attendance. Mr. David Gutheil addressed the Board and referred to a presentation attached hereto as "Exhibit B." Referring to slide 3, Mr. Friedman stated this is a scenario that has been played out across the country and it's a national issue. The national port association has been lobbying Congress to tweak the laws so that ports won't be responsible for paying for Federal facilities. Chairman Holmes asked how much the facility is costing the Port. Mr. Gutheil replied approximately \$1.8 million. The need for the facility is due to the Cleveland-Europe Express. Unfortunately, there is no fee we can implement to recoup the cost of the facility. Chairman Holmes asked if there are any additional costs once they occupy the facility. Mr. Gutheil replied the cleaning fee is nominal. The maintenance fees are a bit harder to predict. He added that ideally we'd like the facility to serve as a TWIC processing facility and a TSA Pre-Check service facility. Mr. Gutheil explained that these are possibilities that we'll discuss with Customs.

Mr. Friedman noted that the Port of Cleveland is the first Port on the Great Lakes to adopt a Climate Action Plan. Director McNair asked how the Climate Action Plan will be controlled since in most instances the Port isn't an asset owner. Mr. Friedman said the plan distinguishes between scopes 1, 2 and 3. Scope 1 includes the Port's assets and what we're able to control; Scope 2 is largely the energy we consume/buy from the market; and Scope 3 is service providers and partners. Goals have been set for each scope. Ms. Carly Beck noted that Scope 3 takes up 80% of the Port's emissions. What makes us unique is that we track emissions for all Scopes, not all ports do.
